# Request for Proposal – City of Greenfield WWTP Aluminum Sulfate

### **Background**

The City of Greenfield Wastewater Utility is seeking proposals for the supply of aluminum sulfate (alum) for the wastewater treatment plant (WWTP). The WWTP has an 8700-gallon double walled bulk storage tank.

### **Proposal Requirements**

- 1. Cost, per gallon delivered, aluminum sulfate solution (49%), iron free. If unavailable, please include the closest concentration available.
- 2. Current safety protocols (i.e.: minimum PPE required for employees, safety checks).
- 3. Detailed description of offloading process.
- 4. Estimated lead time for delivery once an order is placed.
- 5. Schedule a time to visit the facility and inspect the bulk tank and fill connections.
- 6. Proposal shall be clearly marked "Wastewater Utility Alum Pricing Proposal".

#### Terms

All proposals will be reviewed thoroughly and all requirements listed above will be taken into consideration. Safety protocols and method of delivery will be given the same consideration as the price per gallon in determining the most responsible and responsive vendor.

Once the contract is awarded, if at any time, the City or the Utility deems the service provided to be below the safety standards contained within the response to the request for proposals, the City or the Utility reserves of right to then cancel the contract with seven (7) days written notice to the vendor.

## **Proposal Requirements**

Sealed proposals are due to the City of Greenfield Clerk-Treasurer's office, at the address listed below, by 9:30 AM on November 25, 2025 and will be opened at the Board of Public Works and Safety meeting at 10:00 AM the same day. The winning bidder will be notified once the bid has been approved.
