

ADDENDUM No. 1
For City of Greenfield Project 26-WD-01:
SOUTH STREET WATER REPLACEMENT
Issued February 10, 2026

TO: All Plan Holders of Record

The following addendum items modify, change, delete from or add to the requirements of the contract documents for this project. The articles contained in the addendum take precedence over the requirements of the previously published contract documents. Where any article of the contract specifications or any detail of the contract drawings is modified or any paragraph, subparagraph, or clause thereof is modified or deleted by the articles contained in this addendum, the unaltered provisions of that article, paragraph, subparagraph, or clause shall remain in effect. All Quoters shall acknowledge receipt of this Addendum in the space provided on page Quote 4 – Contract Documents and Addenda.

Item No. 1 – Unit Price Quote

This project will be a “Unit Price” project, not a “Lump Sum” project. On February 10, 2024, the Board of Public Works received quotes, but did not open and returned sealed quotes to the Quoters. Unit Price Quotes will be received on 9:30 on February 24, 2024.

Notice To Quoters- Page NTQ-1. Change the first paragraph to read as follows:

*Notice is hereby given that the City of Greenfield will receive sealed quotes for the above described “Project/Work” at Clerk-Treasurer’s Office, 10 S. State Street, Greenfield, Indiana, until 9:30 a.m. prevailing local time, 10 S. State Street, on ~~February 10, 2026~~ **February 24, 2024** and commencing as soon as practicable thereafter on the same date such quotes will be publicly opened. No late Quotes will be accepted.*

Delete and Replace page Quote-2 with the attached page Addendum 1-2. Note change to language in paragraph 2.1 modifying the quote from “LUMP SUM” to “Unit Price”

Modify Page A-3, Contract Price paragraph 2.2 as follows:

- 2.1 ~~***The summation of all***~~ Item Costs for the Contract Items shall be ***used for the basis of payment. equal the Lump Sum amount.*** The submitted Unit Prices for various Contract Items are ***also*** for the purpose of establishing Change Orders. Change Orders are only for substantial changes beyond the intent of the project as illustrated on the project plans and specifications. Any necessary work not specifically itemized shall be considered incidental to any or all Contract Items.

PROPOSAL (QUOTE)

- 2.1 The undersigned Quoter proposes to furnish all necessary labor, machinery, tools, apparatus, materials, equipment, service and other necessary supplies, and to perform and fulfill all obligations incident thereto in strict accordance with and within the time(s) provided by the terms and conditions of the Contract Documents for the above described Work and Project, including any and all addenda thereto, for the **Unit Price** Total of _____ Dollars (\$_____).

For Unit Price Contract Items, estimated quantities and unit prices will serve as the basis for determining the proposed price of each Bid. Patent math errors in statements of Bid prices or totals may be corrected by the Owner, in which case the corrected amounts will be used for the purpose of Bid evaluation, comparison and other award considerations. However, neither the Owner shall be required to discover or correct any error or omission in a Bid and the Bidder shall assume the risk of and be bound to the consequences of any such error or omission.

- 2.2 By submitting quote the Quoter agrees the quote proposal and price(s) contained herein shall be valid for ninety (90) days from quote opening.
