**Tech Review:** Review sheets (Tech Comment Letter) combining all comments received will be emailed the day before the meeting. Tech meetings are on Tuesdays at 1:30pm at City Hall unless adjusted for a holiday

**Public Notice Instructions:** Packets and instructions for completing the mailed and newspaper notice will be provided by staff on or before the dates above for all cases requiring a public hearing.

***All cases must be filed through our online portal with paper copies dropped off to our office by 12 PM EST on the application deadline.***
