Tech Review: BZA Projects may be required to go to technical review meetings, as determined by staff. Those will following the Tech deadlines of the Plan Commission.

Public Notice Instructions: Packets and instructions for completing the mailed and newspaper notice will be provided by staff on the dates above for all cases requiring a public hearing.

All cases must be filed through our online portal with paper copies dropped off to our office by 12 PM
